

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW 1005

WHEREAS, Sec. 1188 of The Municipal Act provides for the cancellation of TAXES owing the municipality;

AND WHEREAS the Council of the Rural Municipality of Morris considers it in the best interests of the municipality to cancel the hereinafter mentioned taxes;

NOW THEREFORE the Council of the Rural Municipality of Morris in regular session assembled, enacts as follows:
