

The Rural Municipality of Morris

BY-LAW NO: 1059

Being a By-law of the R. M. Of Morris to adopt The Morris Planning Scheme 1974.

WHEREAS Section 21, Subsection (4) of the Planning Act, Chapter P80R, S. M. 1970, provides that a Planning Scheme may be varied or revoked by a subsequent Planning Scheme prepared and adopted by a Local Authority or a Responsible Authority, and approved in accordance with the said Act;

AND WHEREAS it is also deemed expedient and desirable to amend The Morris Planning Scheme 1968 as amended.

NOW THEREFORE the Council of the R. M. of Morris in meeting duly assembled enacts as follows:

That the Morris Planning Scheme 1974, designated Schedule 'A' and attached hereto, is hereby approved and adopted and the Reeve and Secretary-Treasurer are hereby authorized to execute the said Planning Sceme and to endorse the approval of Council on the said Planning Sceme under the seal of the R. M. of Morris and to give all further assurances, documents and other instruments that may be necessary, expedient or advisable for the purpose of giving effect to the said Planning Scheme.

Read a second time this 9 day of Aug. A.D. 1974.

SCHEDULE 'A'

THE MORRIS PLANNING SCHEME 1974

1. TITLE This Planning Scheme shall be known as the MORRIS PLANNING SCHEME 1974.
2. AREA The area to which this Planning Scheme shall apply shall be an area located at Rosenort on the north side of P.R. # 205, more particularly described as being part of the S.W. 1/4 of Section 8, Township 6, Range 1, E.P.M., east of and adjacent to Registered Plan No. 11395, this area lying within the dyke, as outline in red on the map entitled Appendix 'A' of the Morris Planning Scheme 1974 amending District Map No. Three of the Morris Planning Scheme 1968 as amended.
3. APPLICATION The provisions of the Morris Planning Scheme 1968 and amendments thereto shall apply to the area except as herein varied.
4. DISTRICT MAP District Map No. Three attached to and being a part of the Morris Planning Scheme 1968 as amended is hereby further amended in order that the area described in Section 2 of the planning scheme presently designated 'A40' Rural District be now redesignated 'RA' Suburban District.
5. INJURIOUS AFFECTION Any claim for injurious affection, as provided by Section 29(1) of the Planning Act, shall be submitted to the Responsible Authority not later than four (4) months from the date of publication of third reading to the By-law adopting this Planning Scheme by the Council of the R. M. of Morris.
6. COMMENCEMENT OF THIS PLANNING SCHEME This Planning Scheme shall be in full force and effect from and after the date on which the By-law adopting this Planning Scheme is given third reading by the Council of the R.M. of Morris and the approval of the Minister of Municipal Affairs.

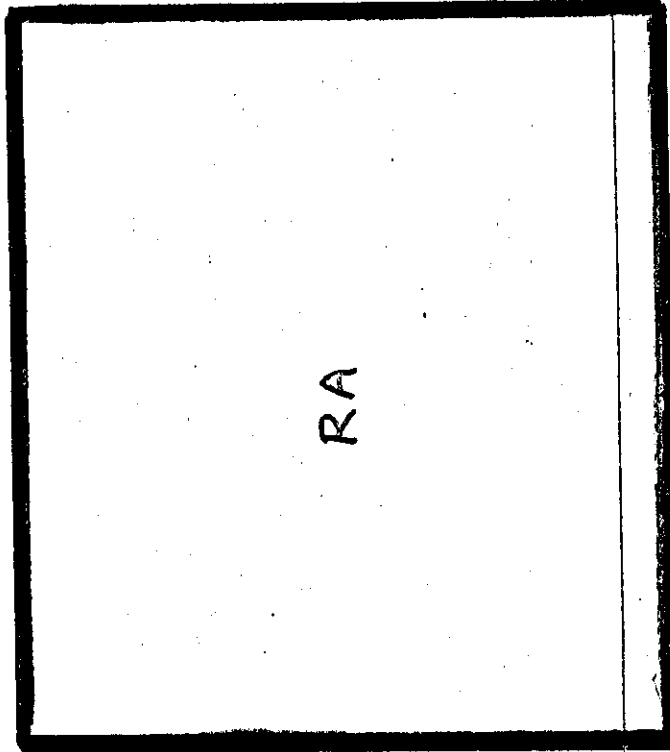

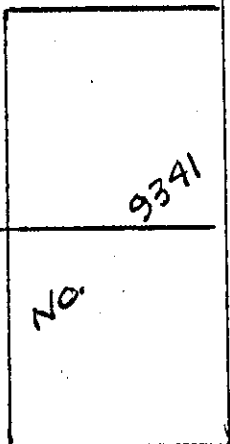
