

THE RURAL MUNICIPALITY OF MORRIS

BY LAW NO. 1113.

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF MORRIS TO PROVIDE FOR THE REMUNERATION OF MEMBERS OF THE COUNCIL.

WHEREAS the Municipal Act, S.M. 1970, C100-Cap. M225, Part III, Division II, Subdivision VI, provides for the remuneration of members of council;

AND WHEREAS it is deemed expedient and in the best interests of The Rural Municipality of Morris to provide for the payment of indemnities and certain expenses to members of Council;

NOW THEREFORE THE COUNCIL OF THE RURAL MUNICIPALITY OF MORRIS, DULY ASSEMBLED IN OPEN COUNCIL, ENACTS AS FOLLOWS:

1. THAT a yearly indemnity of
 - (a) Three Thousand, One Hundred Eighty Dollars (\$3,180.00) be paid to the Reeve; And
 - (b) Two Thousand, One Hundred Dollars (\$2,100.00) be paid to each Councillor.
2. THAT each member of the council, if duly authorized by resolution of the council specifying the purpose, to go on a journey beyond the limits of the corporation on the business thereof, shall be paid the actual expenses in connection with same, together with an indemnity of \$35.00 for a full day, and \$20.00 for a half-day or an evening, while actually engaged in the business. Maximum indemnity for the day to be \$35.00.
3. THAT each member of the council, if duly authorized by resolution of council to attend a meeting of
 - (a) Union of Manitoba Municipalities; or
 - (b) such other organization that in the opinion of the council it is in the interests of the corporation to belong;shall be paid an indemnity of Thirty-Five Dollars (\$35.00) for each day of attendance, and mileage at the rate of 22¢ a mile for travelling to and from such meetings.
4. THAT each member of Council may be paid actual travelling expenses at a mileage rate of Twenty-Two Cents per mile, for each mile, each way, travelled from his place of residence in the municipality to the place of meeting and return to his place of residence, to be allowed only once for each meeting he attends.
5. THAT each member of Council may be paid Six Dollars (\$6.00) per hour, for each hour actually and necessarily spent by him in the performance of such duties, work or services as he is required or authorized to perform; plus actual travelling expenses at the mileage rate of Twenty-Two Cents (\$0.22) per mile, for each mile actually and necessarily travelled by him in the performance of the duties, work, or services authorized, providing that such accounts are verified by statutory declaration and filed with the Clerk, and payment thereof authorized by a resolution of Council.
6. THAT By-Law No. 1090 is hereby repealed.
7. THAT this By-Law shall be in full force and effect on the Eighth Day of February, A.D. 1979.
