

WHEREAS the Council of the Rural Municipality of Morris has received a request to amend the Morris Planning Scheme 1968, as further amended by the Morris Planning Scheme 1971 B;

AND WHEREAS Council deems it expedient and advisable to amend said Scheme;

AND WHEREAS Section 43 of The Planning Act, being Cap. 29 of the continuing consolidation of the Statutes of Manitoba, permits a Municipality to amend its Planning Scheme;

NOW, THEREFORE, be it enacted and it is hereby enacted by the Rural Municipality of Morris, in Council duly assembled, as follows:

1. THAT the following described lands be rezoned from A-40 Agricultural District to R-A Residential District:

"All that portion of the South East Quarter of Section Six, in the Fifth Township and First Range, West of the Principal Meridian, in Manitoba, described as follows: commencing at the intersection of the Northern limit of a plan shown outlined in pink on a plan registered in the Morden Land Titles Office as No. 675 with the Eastern limit of a Public Road as shown on a plan thereof registered in the said Office as No. 510; thence Northerly along said Eastern limit One Hundred feet; thence Easterly and parallel with said Northern limit Two Hundred feet; thence Southerly and parallel with said Eastern limit to said Northern limit; thence Westerly along said Northern limit to the point of commencement;"

2. THAT District Map No. 4 attached to and forming part of the Morris Planning Scheme 1971 B is hereby amended in order that the area described as follows:

"All that portion of the South East Quarter of Section Six, in the Fifth Township and First Range, West of the Principal Meridian, in Manitoba, described as follows: commencing at the intersection of the Northern limit of a plan shown outlined in pink on a plan registered in the Morden Land Titles Office as No. 675 with the Eastern limit of a Public Road as shown on a plan thereof registered in the said Office as No. 510; thence Northerly along said Eastern limit One Hundred feet; thence Easterly and parallel with said Northern limit Two Hundred feet; thence Southerly and parallel with said Eastern limit to said Northern limit; thence Westerly along said Northern limit to the Point of commencement;"

as shewn outlined in a heavy broken line on a plan attached hereto and marked as Schedule "A" to this by-law is hereby reclassified from A-40 Agricultural District to R-A Residential District.

3. THAT the Reeve and the Secretary-Treasurer be and they are hereby authorized to do all things necessary to give force and effect to this by-law.

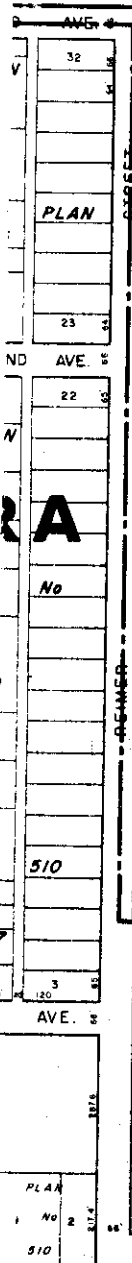
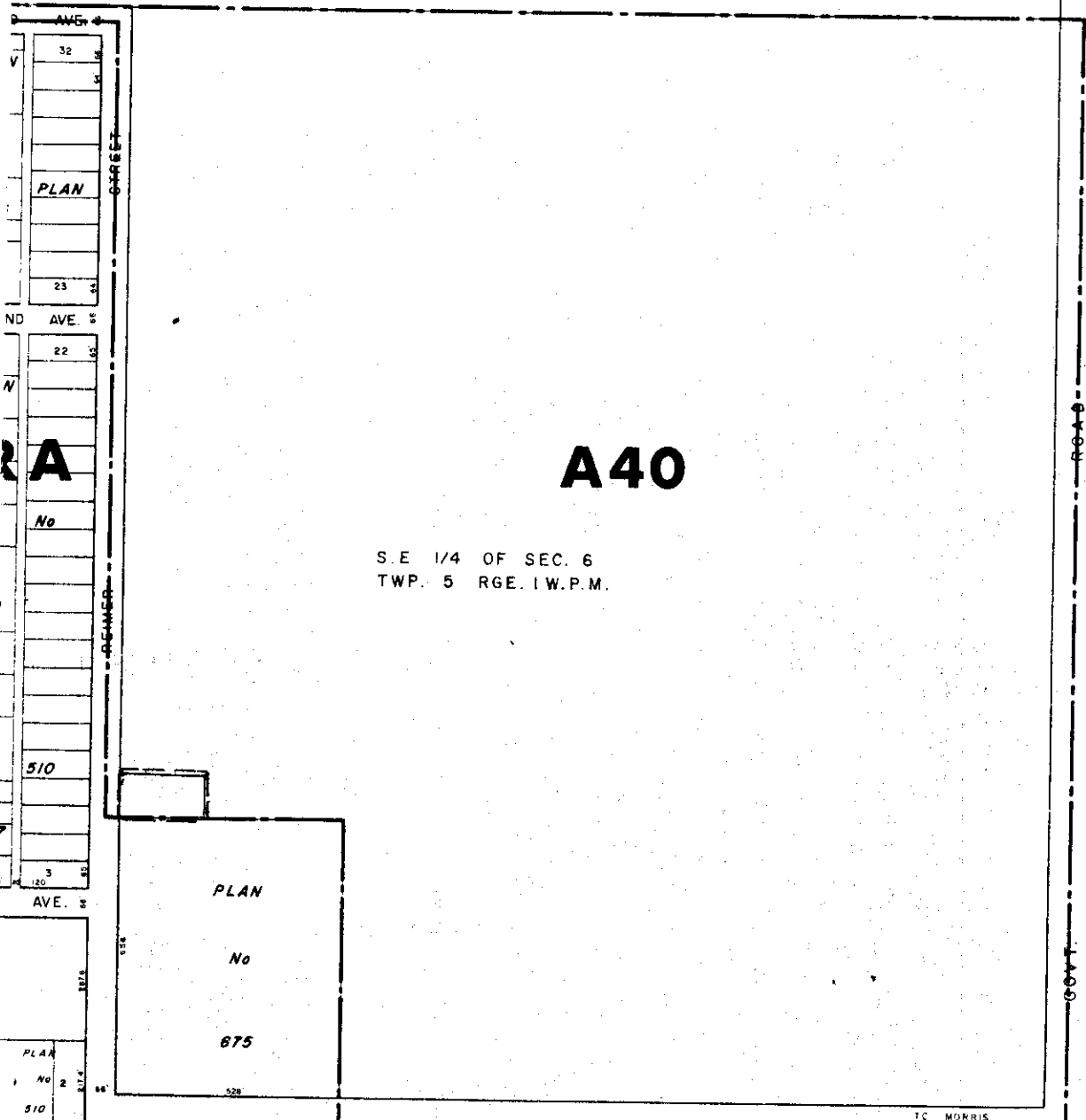
