

Being a By-law of The Rural Municipality of Morris,
relative to the opening of a Highway over and
across part of River Lots 317 and 319, of the
Parish of Sainte Agathe, in Manitoba.

WHEREAS Section 209(1) (a) of The Municipal Act, Chapter M225
of The Continuing Consolidation of Manitoba Statutes, authorizes Council
of a Municipality to pass By-laws for opening, establishing, making,
maintaining and constructing any Highway;

AND WHEREAS the Council of The Rural Municipality of Morris deems
it expedient to establish a Highway across those portions of River Lots
Three Hundred and Seventeen (317) and Three Hundred and Nineteen (319) of
the Parish of Sainte Agathe, in Manitoba, outlined in Red on a Plan of Public
Road prepared by Wilson & Neal, Land Surveyors, File No. 1099-79, and sworn
to by Ian Robson Bowman, Manitoba Land Surveyor, at the City of Winnipeg, in
Manitoba, the 10th day of September, 1979, a copy of which Plan has been
deposited in the office of The Rural Municipality of Morris;

AND WHEREAS the registered owner of the lands to be taken for the
said Highway, has consented thereto and has received satisfactory compensation
therefor;

THEREFORE, NOW, be it and it is hereby enacted as a By-law of The
Rural Municipality of Morris in Council duly assembled, as follows:

1. THAT those portions of River Lots Three Hundred and Seventeen (317)
and Three Hundred and Nineteen (319) of the Parish of Sainte Agathe, in
Manitoba, shewn outlined in Red on a Plan of same, sworn to by Ian Robson Bowman,
Manitoba Land Surveyor, the 10th day of September, 1979, which Plan is hereby
adopted and approved, be and the same are hereby opened up and established as
a Public Highway and dedicated for said purpose.
2. THAT the Secretary-Treasurer of The Rural Municipality of Morris,
be and is hereby authorized to endorse the aforementioned Plan and to affix
thereto the Corporate Seal of The Rural Municipality of Morris and to insert
thereon reference to this By-law and the date of approval.

3. THAT this By-law shall come into force on the date same receives the approval of the Minister, as required under Section 209(7) of The Municipal Act.
