

BY-LAW NO. 1159/81 *J*

WHEREAS the Council of the Rural Municipality of Morris has received a request to amend the Morris Planning Scheme 1968, as further amended by the Morris Planning Scheme 1971 B;

AND WHEREAS Council deems it expedient and advisable to amend said Scheme;

AND WHEREAS Section 43 of The Planning Act, being Cap. 29 of the continuing consolidation of the Statutes of Manitoba, permits a Municipality to amend its Planning Scheme;

NOW, THEREFORE, be it enacted and it is hereby enacted by The Rural Municipality of Morris, in Council duly assembled as follows:

1. That the following described lands be rezoned from RA Suburban District to GC General Commercial District:

"Lot Ten, which lot is shown on a plan of survey of Part of the South West Quarter of Section Eight, in the Sixth Township and First Range, East of the Principal Meridian in Manitoba, registered in the Winnipeg Land Titles Office as No. 5115 excepting thereout the most Westerly Forty feet in perpendicular width thereof."

2. That Appendix "F" attached to and forming part of the Morris Planning Scheme 1971B amending District Map No. 3 attached to and being part of The Morris Planning Scheme 1968 is hereby amended in order that the area described as follows:

"Lot Ten, which lot is shown on a plan of survey of Part of the South West Quarter of Section Eight, in the Sixth Township and First Range, East of the Principal Meridian in Manitoba, registered in the Winnipeg Land Titles Office as No. 5115 excepting thereout the most Westerly Forty feet in perpendicular width thereof."

as shewn outlined in a heavy broken line on a plan attached hereto and marked as Schedule "A" to this by-law is hereby reclassified from RA Suburban District to GC General Commercial District.

3. That the Reeve and the Secretary-Treasurer be and they are hereby authorized to do all things necessary to give force and effect to this by-law.

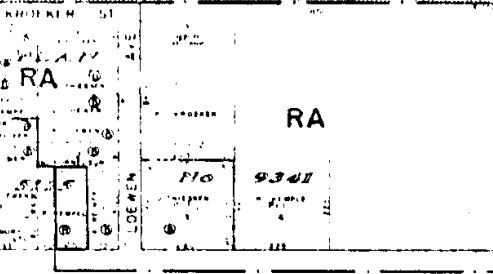

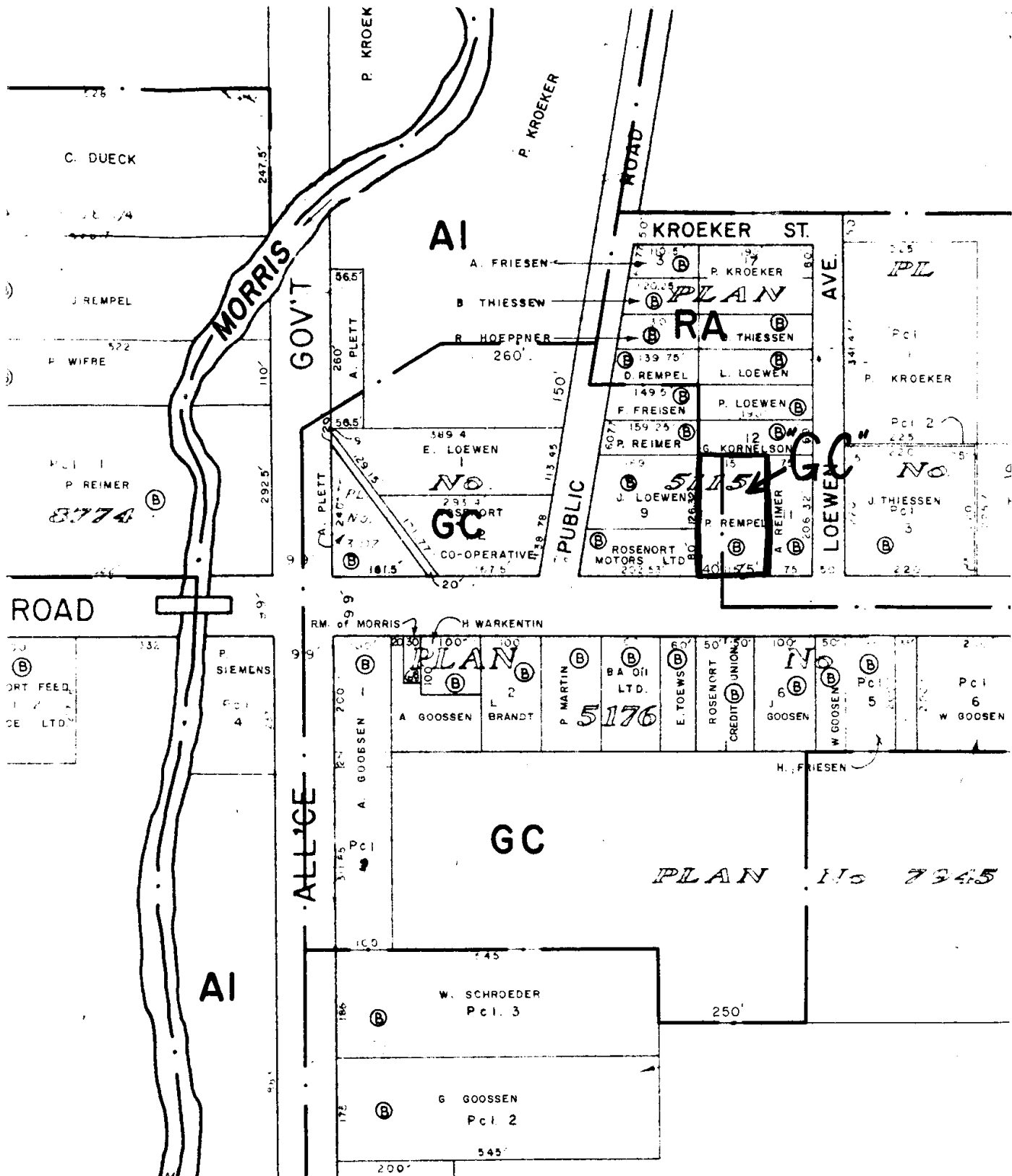
