

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1191/82

BEING a By-law of the Rural Municipality of Morris to provide for the remuneration to members of the Council of the R. M. of Morris.

WHEREAS the Municipal Act, S.M. 1970, C100-Cap. M225, Part 111, Division II, Subdivision VI, provides for the remuneration of members of Council;


AND WHEREAS it is deemed expedient and in the best interests of the Rural Municipality of Morris to provide for the payment of indemnities and certain expenses to members of Council;

NOW THEREFORE, the Council of the Rural Municipality of Morris, duly assembled in open Council, enacts as follows:

1. THAT a monthly indemnity of:
  - (a) Three Hundred and Forty Dollars (\$340.00) be paid to the Reeve; and
  - (b) Two Hundred and Fifty Dollars (\$250.00) be paid to each Councillor
2. THAT each member of the Council, if duly authorized by resolution of the Council specifying the purpose, to go on a journey beyond the limits of the corporation on the business thereof, shall be paid the actual expenses in connection with same, together with an indemnity of \$50.00 for a full day, and \$25.00 for a half day or an evening, while actually engaged in the business. Maximum indemnity for the day to be \$50.00.
3. THAT each member of the Council, if duly authorized by resolution of Council to attend a meeting of:
  - (a) Union of Manitoba Municipalities; or
  - (b) such other organization that in the opinion of the Council it is in the interests of the corporation to belong;shall be paid an indemnity of Fifty Dollars (\$50.00) for each day of attendance, plus the actual living expenses, and mileage at the rate of 32¢ per mile, or 20¢ per kilometer, for travelling to and from such meetings.
4. THAT each member of Council may be paid actual travelling expenses at a mileage rate of Thirty-two Cents per mile, or Twenty Cents per kilometer, for each mile or kilometer, each way travelled from his place of residence in the municipality to the place of meeting and return to his place of residence, to be allowed only once for each meeting he attends.
5. THAT each member of Council may be paid Eight Dollars and Eighty Cents (\$8.80) per hour, for each hour actually and necessarily spent by him in the performance of such duties, work or services as is required or authorized to perform, plus actual travelling expense at the mileage rate of Thirty-two Cents (\$.32) per mile, or Twenty Cents (\$0.20) per kilometer, for each mile, or kilometer actually and necessarily travelled by him in the performance of the duties, work or services authorized, providing that such accounts are verified by statutory declaration and filed with the Clerk, and payment thereof authorized by a resolution of Council.
6. THAT By-law No. 1149/81 is hereby repealed.
7. THAT this By-law shall come into force and effect on the first day of January, A.D. 1982.
