

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1272/83

BEING a by-law of the Rural Municipality of Morris to amend its By-law No. 1243/82.

WHEREAS The Rural Municipality of Morris, by its By-law No. 1243/82, which was authorized by the Municipal Board Order No. F58/83 is, inter alia, authorized to levy a tax on certain lands, as described therein, to the amount necessary to pay the equivalent of 7.65% of the amount required by the Rural Municipality of Richot for principal and interest on the debenture debt for the Ste. Agathe Arena;


AND WHEREAS the levy made and transferred to The Rural Municipality of Richot in 1983 was applied in the reduction of required borrowing by The Rural Municipality of Richot, and, accordingly, the required amount from The Rural Municipality of Morris is reduced;

AND WHEREAS it is therefore deemed expedient to further amend said By-law No. 1243/82 to provide for a reduction in the annual levy as required under said By-law No. 1243/82.

NOW THEREFORE the Council of the Rural Municipality of Morris, duly assembled, enacts as follows:

1. THAT By-law No. 1243/82 of The Rural Municipality of Morris Be And the Same is Hereby Amended to provide that Schedule "B" thereto, being Contribution to Payments under the R. M. of Richot By-law No. 34-82, in the amount of \$2,065.50, be cancelled and be replaced by Schedule "A" hereto in the amount of \$1,820.70.
