

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1301/85

BEING a by-law of the Rural Municipality of Morris to authorize the cancellation of certain local improvement charges.

WHEREAS Section 655 of The Municipal Act provides as follows:

"Upon the coming into force of any by-law making or providing a special tax for a local improvement, the municipality shall not remit the whole or any part of the tax; and the tax shall continue to be a charge upon the lands affected thereby until it is fully paid unless, on application of a ratepayer or the municipality, the board otherwise orders."


AND WHEREAS it is deemed advisable and in the best interests of the Rural Municipality of Morris to cancel certain local improvement charges levied under the authority of By-law No. 1170/81;

NOW THEREFORE, the Council of the Rural Municipality of Morris in Council duly assembled, enacts as follows:

1. That the accounts as noted in Schedule "A" to this By-law be and are hereby cancelled in the records of the Rural Municipality of Morris to the extent of the amounts, and for the reasons shown opposite each item.
2. That the levies so cancelled shall be recovered from the General Funds of the Municipality for the year 1984, and for the balance of the term of By-law No. 1268/83, the deficiency in levies created by such cancellation shall be recovered by a general levy against Local Improvement District No. 2.
3. That this By-law is passed pursuant to Section 655 of The Municipal Act, and shall be valid only after an order authorizing the cancellation as herein provided has been issued by The Municipal Board of the Province of Manitoba.
