

RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1306/85

WHEREAS the Council of the Rural Municipality of Morris wishes to amend the Morris Planning Scheme 1968;

AND WHEREAS Section 95(2) of The Planning Act provides that a planning scheme may be amended;


AND WHEREAS Council deems it expedient and advisable to amend the Morris Planning Scheme 1968;

NOW THEREFORE, the Council of the Rural Municipality of Morris in a meeting duly assembled enacts as follows:


1. That the following described lands be now zoned to that of "R1" One Family District:
Lots 1 to 11, Plan 693
Lot 12 and part of Lot 14, Plan 693
Lots 15 to 29, Plan 693
Lots 11 to 24, Block 5, Plan 522
Lots 11 to 24, Block 4, Plan 522
Lots 13 to 24, Block 3, Plan 522
Block 1, Plan 522
Plan 1116
Lots 1 to 32, Plan 510
Lots 1 to 15, Plan 427
Lots 1 to 4, Plan 505
Lots 5 to 16, Plan 431
Lots 1 to 5 and Lots 22 to 24, all in Block 2, Plan 522
which parcels of land are indicated on Schedule "A" to this By-law.
2. That the Following described lands be now zoned to that of "R3" Mixed-Residential Dwelling District:
Lots 14 to 21, Block 2, Plan 522
which parcels of land are indicated on Schedule "A" to this By-law.
3. That the following described lands be now zoned to that of "O" Open Space District:
Lot 13, Plan 693
West 163 feet of Lot 14, Plan 693
Plan 675
which parcels of land are indicated on Schedule "A" to this By-law.
4. That the following described lands be now zoned to that of "GC" General Commercial District:
Lots 1 to 10, Block 5, Plan 522
Lots 1 to 10, Block 4, Plan 522
Lots 1 to 12, Block 3, Plan 522
Lots 6 to 13, Block 2, Plan 522
which parcels of land are indicated on Schedule "A" to this By-law.
5. That the following described lands be now zoned to that of "C3" Highway Commercial District:
Lots 1 to 4, Plan 431
which parcels of land are indicated on Schedule "A" to this By-law.
6. That the following described lands be now zoned to that of "M2" Heavy Industrial District:
C.N.R. Station Grounds
which parcel of land is indicated on Schedule "A" to this By-law.
7. That Appendix "B" of the Morris Planning Scheme 1971B establishing District Map Four which is amending the District Map One of the Morris Planning Scheme 1968 be hereby amended in accordance to this By-law.

8. That the Reeve and Secretary-Treasurer be and they are hereby authorized to do all things necessary to give force and effect to this By-law.
