

RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1340/87

WHEREAS the Rural Municipality of Morris has a by-law which authorizes the provision of Municipal Assistance to persons in need;

AND WHEREAS this By-law No. 1290/84 has a Schedule "A" which provides the rates by which the municipality is to provide such Municipal Assistance;

AND WHEREAS the Council of the Rural Municipality of Morris wishes to amend clauses (a) to (d) inclusive of Schedule "A" of By-law No. 1290/84;

NOW THEREFORE BE IT ENACTED as a By-law of the Rural Municipality of Morris as follows:

1. That Clause (a) to (d) inclusive of Schedule "A" of By-law No. 1290/84 be now amended to read as follows:

- (a) For Food, but subject to Note 1 of this clause:
- (i) Each Adult \$80.00 per mon
 - (ii) Each person 12 to 17 years of age \$89.36 per mon
 - (iii) Each person 7 to 11 years of age \$73.52 per mon
 - (iv) Each person from birth to 6 years of age . \$56.80 per mon

NOTE 1 Where the household unit consists of three or less beneficiaries, the following additions shall be made:

- (v) For a single person \$16.00 per mon
- (vi) For each of two persons \$ 8.24 per mon
- (vii) For each of three persons \$ 3.84 per mon

- (b) For Clothing, but subject to Notes 1 and 2 of this clause:
- (i) Each Adult \$21.76 per mon
 - (ii) Each person 12 to 17 years of age \$27.76 per mon
 - (iii) Each person 7 to 11 years of age \$18.72 per mon
 - (iv) Each person from birth to 6 years of age. \$18.72 per mon

NOTE 1 Each child not living with his own family, the actual cost as required and authorized by the municipality.


NOTE 2 For each employed adult an amount of \$14.10 per month may be added.

- (c) For Personal Needs for adult recipients:
- (i) When the household consists of more than one beneficiary \$26.40 per mont
 - (ii) When the household consists of a single beneficiary \$35.68 per mont
 - (iii) For a patient in hospital or other prescribed institute \$16.90 per mont

- (d) For Household Supplies:
- (i) For each household unit \$ 7.04 per mont
 - (ii) For each person in a household unit after the first \$ 2.32 per mont

2. That this By-law shall come into force and take effect upon the date receives the approval of Council.
