

RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1371/89

BEING a by-law of the Rural Municipality of Morris relative to the expansion of the boundaries of the Unincorporated Village District of Rosenort.

WHEREAS the Unincorporated Village District of Rosenort was created by By-law No. 1083 of the Rural Municipality of Morris in 1977;

AND WHEREAS the Unincorporated Village District of Rosenort Committee has requested the expansion of the U.V.D. of Rosenort boundaries;


AND WHEREAS the Council of the Rural Municipality of Morris has received a certified copy of a resolution from the U.V.D. of Rosenort Committee and a petition signed by a majority of the electors of the U.V.D. of Rosenort and a petition signed by a majority of the electors of the area which is proposed to be added to the U.V.D. of Rosenort:


AND WHEREAS it is the opinion of Council that the conditions of Section 599(2) of the Municipal Act have been complied with and that this by-law shall accommodate the boundary expansion request for the U.V.D. of Rosenort.

NOW THEREFORE BE IT ENACTED that the Council of the Rural Municipality of Morris, enacts as follows:

1. That the Rural Municipality of Morris consents to and authorizes the expansion of the boundaries of the Unincorporated Village District of Rosenort according to Schedule "A" attached hereto and forming part of this by-law.
2. That the land areas stated in Schedule "A" attached hereto shall be in addition to the existing land area of the U.V.D. of Rosenort and that this alteration of the boundaries shall be effective as of January 1st, 1990.
3. That the Reeve and Secretary-Treasurer be and are hereby authorized to do all things necessary to give force and effect to this by-law.

SCHEDULE "A" TO BY-LAW NO. 1371/89 OF THE R. M. OF MORRIS

- Parcel A - Commencing at the North West corner of the SE $\frac{1}{4}$ of Section in Township 6 and Range 1 E.P.M., thence Easterly along the Northern boundary of the said SE $\frac{1}{4}$ to a point on the centre line of the road allowance, thence Southerly along the centre line of the road allowance to a point parallel with and perpendicular to the Southern boundary of the NE $\frac{1}{4}$ of Section in Township 6 and Range 1 E.P.M., thence Westerly along the Southern boundary of the NE $\frac{1}{4}$ of Section 5, in Township 6 and Range 1 E.P.M. to the Southwest corner of the said quarter Section, thence Northerly along the Western limit of the Northeast quarter of Section 5 and continuing Northerly along the Western boundary of the Southeast quarter of Section 8 to the point of commencement.
- Parcel B - Commencing at the North West corner of the SE $\frac{1}{4}$ of Section in Township 5 and Range 1 E.P.M., perpendicular distance Easterly thereon Four Hundred feet from the Western limit of the Southwest quarter of said Section 32, thence Southerly and Parallel to the said Western limit of said Southwest quarter of said Section 32 to intersect a line drawn North East of, parallel with and perpendicularly distant Four Hundred feet from the North Eastern limit of the land taken for road as the same is shown on a plan of survey filed in the Winnipeg Land Titles Office as No. 4516, thence Southeasterly along the last described line to the centre line on the road allowance, thence Westerly along the said centre line of the road allowance to the centre line of the Morris River; thence upstream along the course of the said centre line of the said Morris River to its intersection with the Northern limit of the Southeast quarter of Section 31, in Township 5 and Range 1 E.P.M., thence Easterly along the Northern boundary of the Southeast quarter of Section 31, Township 5 and Range 1 E.P.M., and continuing Easterly along the Northern limit of the Southwest quarter of Section 32, Township 5 and Range 1 E.P.M. to the point of commencement
- Parcel C - All of Lot 7, in Plan 17381 located within the Northwest quarter of Section 32, in Township 5 and Range 1 E.P.M.
- Parcel D - From the intersection of the centre line of the Morris River and the centre line of the Little Morris River to the Western limit of the East half of said Section 6, Township and Range 1 E.P.M., thence Northerly along the said Western limit of the East half of said Section 6 to the Northern limit of said Section 6, and to the centre line of the road allowance, thence Easterly along the centre line of the road allowance to a point perpendicular to the Western limit of Parcel 8, in Plan 8774, thence Northerly to the Southwest corner of Parcel 8, in Plan 8774, thence Easterly along the Southern boundary of Parcel 8 following the existing boundary of the Unincorporated Village District of Rosendor to the centre line of the Morris River, thence Southerly along the centre line of the Morris River to the point of commencement.
- Parcel E - Commencing along the Western limit of the straight line production Northerly of the said Parcel 8, in Plan 8774 to the Northern limit of Lot 5, Block 1, in Plan 16236, thence Easterly along the said Northern limit of said Lot to intersect a line drawn Northerly from the Western limit of Parcel 3, in Plan 8774, thence Southerly to the Southwest corner of Parcel 4, in Plan 8774, thence West along the Northern limit of Lots 6, 7, 8, in Plan 8774 to the point of commencement.
