

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1400/91

BEING a By-law of the Rural Municipality of Morris to provide for the remuneration of members of the Council of the R. M. of Morris.

WHEREAS the Municipal Act, L.R.M. 1988, c. M225, Part III, Division VI, provides for the remuneration of members of Council;

AND WHEREAS it is deemed expedient and in the best interest of Rural Municipality of Morris to provide for the payment of indemnities and certain expenses to members of Council;

NOW THEREFORE, the Council of the Rural Municipality of Morris assembled in open Council, enacts as follows:

1. THAT a monthly indemnity of
a) Four Hundred and Seventy Five Dollars (\$475.00) be paid to the Reeve
b) Three Hundred and Fifty Dollars (\$350.00) be paid to each Councilor.

2. THAT each member of the Council, if duly authorized by resolution of the Council specifying the purpose, to go on a journey outside the limits of the corporation on the business thereof, shall be paid actual expenses in connection with same, together with an indemnity of \$80.00 for a full day, and \$40.00 for a half day or an evening, while actually engaged in the business. Maximum indemnity for the day to be \$120.00.

3. THAT each member of Council if duly authorized by resolution of Council to attend a meeting of
a) Union of Manitoba Municipalities; or
b) such other organization that in the opinion of the Council it is in the interests of the corporation to belong, shall be paid an indemnity of Eighty Dollars (\$80.00) for each day of attendance, plus the actual living expenses, and mileage at the rate of 45 cents per mile or 28 cents per kilometer, for travelling to and from the meeting.

4. THAT each member of Council may be paid actual travelling expenses at a mileage rate of Forty-Five Cents per mile or Twenty-Eight Cents per kilometer, for each mile or kilometer, each way travelled from his place of residence in the municipality to the place of the meeting and return to his residence, to be allowed only once for each meeting he attends.


5. THAT each member of Council may be paid Twelve Dollars and Thirty-Five Cents (\$12.35) per hour, for each hour actually worked and necessarily spent by him in the performance of such duties, work or services as he is required or authorized to perform, plus actual travelling expenses at the mileage rate of Forty-Five Cents (\$.45) per mile or Twenty-Eight Cents (\$.28) per kilometer, for each mile or kilometer actually and necessarily travelled by him in the performance of the duties, work or services authorized, providing that such accounts are verified by statement of declaration and filed with the Clerk, and payment thereof authorized by resolution of Council.

6. THAT By-law No. 1381/90 is hereby repealed.

7. THAT this By-law shall come into force and take effect on the first day of January, A.D. 1991.
