

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1418/92

BEING a By-law of the Rural Municipality of Morris providing for raising moneys by a special tax to augment the reserve fund for the Machinery Replacement Reserve Fund created by By-law No. 1339.

WHEREAS subsection (2) of Section 574 of The Municipal Act, S.M. 1970, provides in part:


- "574(2) A reserve fund may beaugmented
- (a) ...
 - (b) by moneys raised by a special tax, over and above the current requirements of the municipality, levied for such term of years as the minister approves,
 - (i) at such a rate as the minister approves and is specified in a by-law; or
 - (ii) to raise such amount as the minister approves, and is specified in a by-law;"

AND WHEREAS it is deemed expedient and in the best interest of the Rural Municipality of Morris to raise a special tax to augment the Reserve Fund for the Machinery Replacement Reserve Fund;

THEREFORE BE IT RESOLVED that the Council of the Rural Municipality of Morris, duly assembled, enacts as follows:

1. THAT in each of the years 1992 to 1994, both inclusive, there shall be levied upon the assessed value of all the rateable property in the municipality liable therefore a special rate of 1.94 mills on the dollar, the product of which shall be deposited annually in, and form part of, the said Reserve Fund;
2. THAT By-law No. 1391/90 shall be hereby rescinded.
3. THAT this by-law shall come into force and take effect upon the date it receives the approval of the Minister of Rural Development.
