

THE RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 1484/95

BEING a By-law of the Rural Municipality of Morris to acquire title to properties in Rosenort, Manitoba for recreation purposes.

WHEREAS the Community of Rosenort, Manitoba desires to establish an area for the purpose of recreation and the construction of such recreation facilities;

AND WHEREAS this land forming this recreation area is being subdivided from Lot 6, Block 1, Plan 16236 and Lot 4, Plan 27281 and Parcel 8, Plan 8774 as is currently described and which is to be described as Lot 3, Plan \_\_\_\_\_ W.L.T.O., being part of the SE $\frac{1}{4}$  of Section 7-6-1EPM;

AND WHEREAS it is desired that this property be registered in the name of the Rural Municipality of Morris;

AND WHEREAS the Council of the Rural Municipality of Morris is in agreement that this property be registered at the Winnipeg Land Titles Office under the name of the Rural Municipality of Morris;

AND WHEREAS the Community of Rosenort has raised sufficient fund to purchase this property and it is the acknowledgment of all that this property remain the ownership of the Rosenort Community;

NOW THEREFORE BE IT ENACTED, and it is hereby enacted as a by-law of the Rural Municipality of Morris, in Council, duly assembled as follows:

1. That the property in question to be in the name of the Rural Municipality of Morris is currently described as the East 1075 feet of Lot 6, Block 1, Plan 16236 and the East 1075 feet of Lot 4, Plan 27281 and also the East 66 feet of Parcel 8, Plan 8774 currently noted at Winnipeg Land Titles Office under File No. 1092/95 and which this property will become Lot 3, Plan \_\_\_\_\_ W.L.T.O., being part of the SE $\frac{1}{4}$  of Section 7-6-1 EPM.
2. That Rosenort Community Centre Incorporated shall be responsible for the monetary amounts required to purchase the property and shall also be responsible to pay all legal and other costs incurred in connection with this transaction.
3. That this property shall be for the designated use of recreational uses and facilities.
4. That the Rural Municipality of Morris accepts title to this property with the understanding that future ownership and responsibility shall remain that of the Community of Rosenort.

5. That the Reeve and the Secretary-Treasurer be and they are hereby authorized to do all things necessary and required to give force and effect to this by-law.
