

By-Law No. 589 of the Rural Municipality of Morris authorizing
the Assignment of the Tax Sale Certificate No. 103,
covering the West half of North West 9-5-2 West.

WHEREAS the Rural Municipality of Morris did purchase
at the 1932 Tax Sale of the said Municipality, the following
land namely, the West half of the North West quarter of
Section Nine (9) in Township Five (5) and Range Two (2) West
of the Principal Meridian in Manitoba, and Tax Sale Certificate
No. 103, dated the 14th day of December 1932, was issued in
respect thereof.

AND WHEREAS Agnes E. Osgood of the Town of Marseilles
in the State of Illinois, U.S.A. Widow, has applied for an
assignment of the said Tax Sale Certificate and the proceedings
taken thereunder.

AND WHEREAS the said Agnes E. Osgood has paid to the
Municipality of Morris the amount for which the said land was
sold, together with all penalties and subsequent costs in
connection with the said Certificate and application for Title.

NOW THEREFORE, be it enacted as By-Law No. 589 of the
Rural Municipality of Morris, that it assign, transfer and set
over unto the said Agnes E. Osgood, all it's right, title and
interest in and to the said Tax Sale Certificate, and the
proceedings taken thereunder and that the Reeve and Secretary
Treasurer be authorized to sign and seal the necessary Assignment.

THE RURAL MUNICIPALITY OF MORRIS

Hereinafter called the Assignor
of the FIRST PART.

Agnes E. Osgood of the Town of Marseilles
in the State of Illinois, U.S.A. Widow,

Hereinafter called the Assignee
of the Second Part.

WHEREAS the Rural Municipality of Morris purchased at
the sale of land for taxes held by the said Municipality of
Morris, on the 14th day of December 1932, the following land:

The West half of the North West quarter of
Section Nine (9) in Township Five (5) and
Range Two (2) West of the Principal Meridian
in the Province of Manitoba.

AND WHEREAS Agnes E. Osgood of the Town of Marseilles
in the State of Illinois, U.S.A., Widow, has requested the
Rural Municipality of Morris to assign to her the Tax Sale
Certificate covering the said land and all its interest in
the said land as Tax Sale Purchaser.

AND WHEREAS the Rural Municipality of Morris has agreed
to comply with such request on receiving payment from the
said Agnes E. Osgood of the amount for which the said land was
sold for taxes, together with penalties, interest and costs due
under the said Tax Sale Certificate.

NOW THEREFORE THIS INDENTURE WITNESSETH that in consider-
ation of the premises and the sum of One Hundred and Ninety
Two and 24/100 Dollars (\$192.24) paid by the said Agnes E.
Osgood to the Rural Municipality of Morris, the receipt of
which sum is hereby acknowledged, the Rural Municipality of
Morris doth hereby assign, transfer and set over unto the
said Agnes E. Osgood the Tax Sale Certificate dated December
14th, 1932, covering the above described parcel of land.
