

BY-LAW No. 608

WHEREAS Section 206 of "The Assessment Act" provides as follows -

(1) A Municipality by by-law may cancel in whole or in part of any taxes or any debt or moneys owing to the Municipality.

(2) No by-law passed under this section shall have any force or effect until the minister certifies that evidence has been filed with him establishing the bona fides of the by-law and that it is in the best interest of the Municipality.

AND WHEREAS the Council of the Rural Municipality of Morris consider that it is in the best interest of the Municipality to cancel the hereinafter mentioned hospitals accounts amounting to \$26,637.52 and owing to the Municipality.

NOW THEREFOR the Reeve and Council of the Rural Municipality of Morris in Council assembled enact as follows:-

That the Hospital accounts owing to the Municipality and mentioned in Schedule A, be and are hereby cancelled.

Done and passed in Council assembled at the Council Chamber of the Rural Municipality of Morris at Morris in Manitoba this 21st, day of November A.D. 1938.
