

BY-LAW NO. 621

A By-Law of the Rural Municipality of Morris to assign Tax Sale Certificate No. 119 dated the Fourteenth day of December A. D. 1932, covering the South-East Quarter of Section Twenty-Four (24) in Township Five (5) and Range Two (2) West of the Principal Meridian in Manitoba.

WHEREAS there are Arrears of Taxes including Interest and Penalties owing on the above described land under Tax Sale Certificate Number 119 aforesaid.

AND WHEREAS Walter S. ^{Selkirk}Newton of the City of Winnipeg, in the Province of Manitoba, Liquidator of the Summerfeld Waisenamt (in Liquidation), has paid to the Said Municipality the Sum of Three Hundred and Seventeen Dollars and Eight Cents (\$317.08) the Amount owing as aforesaid.

AND WHEREAS the Said Walter S. ^{Selkirk}Newton has asked for an Assignment of the Said Tax Sale Certificate and the Said Municipality is willing to grant his request:

NOW THEREFORE, the Council of The Rural Municipality of Morris enacts as follows:

- (1) That the Said Rural Municipality of Morris do assign Tax Sale Certificate Number 119, dated the Fourteenth day of December A. D. 1932 and covering the South-East Quarter of Section Twenty-Four (24) in Township Five (5) and Range Two (2) West of the Principal Meridian in the Province of Manitoba to Walter S. Newton of the City of Winnipeg in Manitoba aforesaid Liquidator of the Summerfeld Waisenamt (in Liquidation) and the Said Certificate is hereby assigned. AND,
- (2) That the Reeve and Secretary-Treasurer of the Said Municipality be authorized to sign and Seal the necessary Documents in this behalf.
