

By-law No. _____ of the Rural Municipality of Morris, authorizing assignment of Tax Sale Certificate No. 9, covering S. W. $\frac{1}{4}$ 7-6-2 West.

WHEREAS The Rural Municipality of Morris did purchase at the 1940 Tax Sale of the said Municipality the following land, namely: The South West Quarter of Section seven (7) in Township six (6) and Range two (2) West of the Principal Meridian, and Tax Sale Certificate No. 9, dated the 12th day of December, 1940, was issued in respect thereof.

AND WHEREAS the Huron and Erie Mortgage Corporation has applied for an assignment of the Tax Sale Certificate and the proceedings taken thereunder.

AND WHEREAS the Huron and Erie Mortgage Corporation has paid to the Municipality the amount for which the said land was sold together with all penalties and subsequent costs in connection with the said Certificate and application for Title.

NOW, THEREFORE, be it enacted as By-law No. _____ of the Rural Municipality of Morris, that it assign, transfer and set over unto the said Huron and Erie Mortgage Corporation all its right, title and interest in and to the said Tax Sale Certificate and the proceedings taken thereunder and that the Reeve and Secretary-treasurer be authorized to sign and seal the necessary assignment.

PASSED AND ENACTED as by-law No. *666* of the Rural Municipality of Morris at a Meeting of the Council of the said Municipality held on the 13th day of November, 1942.

WHEREAS The Rural Municipality of Morris purchased at
the sale of land for taxes held by the said Municipality on the
12th day of December, 1940, the following land, namely:

The South West Quarter of Section seven (7)
in Township six (6) and Range two (2) West
of the Principal Meridian, in the Province
of Manitoba.


AND WHEREAS the Huron and Erie Mortgage Corporation
has requested the Rural Municipality of Morris to assign to it
the Tax Sale Certificate covering the said parcel of land
and all its interest in the said land as Tax Sale purchaser.

AND WHEREAS the Rural Municipality of Morris has
agreed to comply with such request on receiving payment from
the Huron and Erie Mortgage Corporation of the amount for which
the said land was sold for taxes together with penalties,
interest and costs due under the said Tax Sale Certificate.

NOW, THEREFORE, THIS INDENTURE WITNESSETH that in
consideration of the premises and the sum of Two hundred and
eight Dollars and forty-five (\$208.45) cents paid by the
Huron and Erie Mortgage Corporation to the Rural Municipality
of Morris, the receipt of which sum is hereby acknowledged,
the Rural Municipality of Morris doth hereby assign, transfer
and set over unto the said Huron and Erie Mortgage Corporation
the said Tax Sale Certificate covering the said parcel of land
and proceedings taken pursuant to said Certificate.
