

RURAL MUNICIPALITY OF MORRIS

BY-LAW NO. 687

A BY-LAW of the Rural Municipality of Morris re the cancellation of certain taxes.

WHEREAS Section 1196 (1) of the "Municipal Act" - 1940 - provides as follows:

1. A Municipality by by-law may cancel in whole or in part any taxes or any debt or moneys owing to the Municipality.
2. No by-law passed under this section shall have any force or effect until the Minister certifies that evidence has been filed with him establishing the bona-fides of the by-law, and that it is in the best interest of the Municipality.


AND WHEREAS the Council of the Rural Municipality of Morris considers that it is in the best interest of the Municipality to cancel the herein after mentioned taxes amounting to \$594.24 and owing to the said Municipality.

NOW THEREFORE the Reeve and Council of the Rural Municipality of Morris, in session, enacts as follows:

THAT the tax accounts owing to the said Municipality as set forth in Schedule "A" hereto attached, and forming part of this by-law, be and are hereby cancelled.
