

BY-LAW No.744 of the Rural Municipality of Morris.

BY-LAW No.744 of the Rural Municipality of Morris, being a BY-LAW for the purpose of cancelling certain taxes.

Whereas, Section 1196 of "The Municipal Act", 1940, provides as follows:

- (1) A Municipality by By-Law may cancel in whole or in part any taxes or any debt or moneys owing to the Municipality.
- (2) No By-Law passed under this section shall have any force or effect until the Minister certifies that evidence has been filed with him establishing the bona-fides of the By-Law, and that it is in the best interests of the Municipality.

And Whereas, the Council of the Rural Municipality of Morris considers that it is in the best interests of the Municipality to cancel the hereinafter mentioned taxes owing to the Municipality.

Now therefore, the Reeve and Council of the Rural Municipality of Morris in open session, enacts as follows:-

(a) That the following taxes be cancelled as they were respectively wrongly assessed and/or wrongly taxed accordingly; and considered uncollectable :
