

BY-LAW No. 782

BY-LAW No. 782, being a BY-LAW of the Rural Municipality of Morris, for the purpose of fixing a place of meeting of the Council of the Rural Municipality of Morris, fixing the remuneration to be paid to the Reeve and Councillors and the date of holding the regular meetings of the Council for the year 1953. -

Now therefore, be it enacted and it is hereby enacted as and for BY-LAW No. 782 of the Rural Municipality of Morris as follows:-

That the Reeve and Councillors shall be paid for their services as follows:-

For attending each meeting of the Council, \$6.00; and ten cents per mile for each mile travelled to and from the place of meeting, providing that the indemnity shall not exceed for all purposes, except mileage, the sum of \$150.00 in one year as provided by the "Municipal Act".

Should it be expedient at any regular meeting to change the date of the next regular Council meeting to an earlier or later date than the date set by this BY-LAW, the Council may do so if carried by a majority of the members present.

Special meetings of the Council may be convened at any time by the Reeve and Two members of the Council by giving, before the day of the meeting, a reasonable notice of such meetings to all members of the Council. Such notices may be verbal or in writing sent by registered mail to address of the members of the Council, or notice may be delivered by some person employed to deliver such notices. Each notice of special meeting shall contain notice of the subjects which are to be taken up at the Special meeting.

The Council of the Rural Municipality of Morris shall hold its' regular meeting in the County Court House in the Town of Morris, in Manitoba on the *2nd Friday* in each month, commencing at the hour of *10⁰⁰* o'clock A.M. and if there is no quorum at the expiration of two hours of the time appointed for the meeting, the Council Meeting shall stand adjourned to the next meeting thereof, and the Clerk shall enter in the minutes, the names of the persons present.

The Reeve of the Municipality shall preside at all meetings of the Council or in his absence, a deputy Reeve appointed by the Council shall preside, who shall have the same authority and exercise the same functions in presiding, as the Reeve would have.

Should the Reeve or any of the Councillors be appointed by resolution to go to Winnipeg or any other place on business of the Municipality, they shall be paid the sum of \$6.00 per day and actual travelling expenses.

The Reeve and any of the Councillors shall be paid 75 cents per hour and 10 cents per mile necessarily travelled for inspection or in performing work or other services in respect to roads, bridges or other public works in or for the Municipality, providing that all amounts for such work be verified by Statutory Declaration, which have been filed with the Clerk of the Municipality, and a resolution of the Council passed, authorizing payment of same, as well as previous authority from the Council to do the work.
