* BY-LAW NO. 796 *

By-Law No. 796 of the Rural Municipality of Morris, being a By-Law for the purpose of cancelling certain taxes.

WHEREAS, under Section 1196 of "The Municipal Act", a Municipality may cancel in whole or in part any taxes owing to the Municipality,

AND WHEREAS the Council of the Rural Municipality of Morris considers that it is in the best interests of the Municipality to cancel such taxes,

NOW THEREFORE, the Council of the Rural Municipality of Morris in session assembled, enacts as follows:

THAT the taxes as referred to in "Exhibit A" attached hereto, should be cancelled, as they are considered uncollectable for reasons as given.
