

BY-LAW NO. 813A

BEING a By-Law of the Rural Municipality of Morris relative to the closing of a Public Road within its confines, and being " All those portions of the South West Quarter of Section Twelve (12) in Township Six (6) and Range One (1) West of the Principal Meridian in the Province of Manitoba, taken for a Public Road as same is shewn colored Pink on a Plan of same filed in the Winnipeg Land Titles Office as No.1498 AND FOR the opening, establishing and maintaining of a Public Road over and across the aforesaid Quarter Section, and being all those portions of same as shewn colored Pink on a Plan of same made by ~~Ross Fisher~~ <sup>Charles Dudley Brown</sup> M.L.S. and sworn to on the ~~12th~~ <sup>2nd</sup> day of ~~October~~ <sup>September</sup> A.D.1954.

WHEREAS under the provisions of the Municipal Act being Cap 141.R.S.M.1940 and amendments thereto, every Municipal Corporation may pass by-laws for the closing, opening, establishing and maintaining Public Roads within its confines.

AND WHEREAS the Council of the Municipality of Morris desires-

FIRSTLY- to close all those portions of the aforesaid Quarter Section, taken for a Public Road as shewn colored Pink on a Plan of same filed in the Winnipeg Land Titles Office as No.1498.,

and SECONDLY- to open, establish and maintain as a Public Road on the aforesaid Quarter Section all those portions as shewn on a Plan of same, colored Pink, and made by ~~Ross Fisher~~ <sup>Charles Dudley Brown</sup> M.L.S. and sworn to on the ~~12th~~ <sup>2nd</sup> day of ~~October~~ <sup>September</sup> A.D.1954.

AND WHEREAS due publication of notice of the passing of this by-law has been given in compliance with Section 471 of the aforesaid Municipal Act.

AND WHEREAS- no person or persons, by agent or otherwise has appeared as at the date of the passing of this by-law, claiming that his land would be prejudicially affected by the passing of this by-law.

NOW THEREFORE- the Council of the Rural Municipality of Morris in meeting duly assembled enacts as follows-

FIRSTLY- That all those portions of the South West Quarter of Section Twelve (12) in Township Six (6) and Range One (1) West of the Principal Meridian in the Province of Manitoba as shewn colored Pink on a Plan of same filed in the Winnipeg Land Titles Office as No.1498 be closed.

SECONDLY- That a Public Road be opened, established and maintained, over and upon all those portions of the aforesaid Quarter Section, as shewn colored Pink on a Plan of same made by Charles Dudley Brown ~~Charles Dudley Brown~~, M.L.S. and sworn to on the ~~15th~~<sup>2nd</sup> day of ~~September~~<sup>September</sup> A.D. 1954.

AND that the Reeve and Secretary-Treasurer of this Municipality be, and are hereby authorized, instructed and empowered on behalf of the said Municipality to execute all necessary documents relative thereto, and for the transference if necessary of all those portions of land in the old road to be closed, and for the acquisition of all those portions to be taken for the new road to be opened in the name of Her Majesty the Queen in Right of the Province of Manitoba.
