

A By-law of the Rural Municipality of Morris for submitting to the resident ratepayers by-law No. 826 of the said Municipality providing for the raising of additional moneys for the establishment of further hospital facilities for Altona Hospital District No. 24.

WHEREAS By-law No. 826 of the Rural Municipality of Morris, entitled "By-law of the Rural Municipality of Morris to authorize the raising of additional moneys for the establishment of further hospital facilities for Altona Hospital District No. 24" has been introduced and read a first time by the Municipal Council for the Rural Municipality of Morris;

AND WHEREAS it is necessary that such By-law receive the assent of the resident ratepayers of the Rural Municipality of Morris before the final passing thereof and it is expedient that it be submitted to the said resident ratepayers to be voted on <sup>on</sup> the 28th day of June, A.D. 1956;

AND WHEREAS the said By-law has been approved by the Minister of Health and Public Welfare and by the Municipal and Public Utility Board;

AND WHEREAS the said By-law No. 826 was given a second reading by the Council Meeting held at the Rural Municipality of Morris on the <sup>1st</sup> day of June, A.D. 1956;

AND WHEREAS the Municipal Act provides that in such case the Municipality shall fix the day and hour and the place for taking the votes of the resident ratepayers on that by-law;

AND WHEREAS the Municipality has fixed the time and place for taking the vote on the said By-law as hereinafter set forth;

NOW THEREFORE, the Rural Municipality of Morris, in Council assembled, enacts as follows:

1. That a vote for or against the passing of the said By-law No. 826 be taken on Thursday the 28th day of June, A.D. 1956 between the hours of nine o'clock in the forenoon and six o'clock in the afternoon at Steinfeld School, situated on the NW $\frac{1}{4}$  of Section eight, Township four, Range one, West. of all the resident ratepayers of the said Municipality of Morris residing in the withing described area:

Sections 1, 2, 3, 4, and 5, in Township 4, Range 2, and Sections 2, 3, 4, 5, and 6, in Township 4, Range 1, all West of the Principal Meridian, and all in the Rural Municipality of Morris.

2. The said voting shall take place at the polling place fixed by the Rural Municipality of Morris as aforesaid.

3. On Tuesday, the 26th day of June, A.D. 1956, the Reeve will attend at the Municipal Hall in the Town of Morris, in the Province of Manitoba between the hour of eleven o'clock in the forenoon and twelve o'clock noon for the purpose, if requested, of appointing persons to attend at the final summing up of the votes; and one person to attend at each of the said polling places on behalf of persons interested in promoting or opposing the said by-law respectively.

4. The Secretary-Treasurer of the Rural Municipality of Morris will attend at <sup>his office in Morris</sup> ~~the Steinfeld School, situated on the NW 1/4 of Section eight, Township four, Range one, West,~~ in the Province of Manitoba, at the hour of six o'clock in the afternoon on Thursday, the 28th day of June, A.D. 1956, to sum up the number of votes for and against the said By-law.

5. That this by-law come into force on the day of the passing thereof.
