

BEING A BY-LAW of the Rural Municipality of Morris relative to the closing of a Public Road within its confines and being, "All that portion of a Public Road between River Lots 495 and 497 of the Parish of St. Agathe in the Province of Manitoba, which lies to the East of the production Northerly in a straight line of the Eastern limit of the Public Road as shewn colored Pink on a Plan of same registered in the Winnipeg Land Titles Office as No. 4968, AND FOR the opening establishing and maintaining of a Public Road over and upon all those portions of the South Half of River Lot 493 and the North Half of River Lot 491 both in the Parish of St. Agathe in the Province of Manitoba as shewn outlined in red on a Plan of same made by Chester Gabriel Wesley M.L.S. on the 23rd and 24th days of September A.D. 1957 and sworn to before A. Lorne Campbell.

WHEREAS under the provisions of Section 480 of the Municipal Act being Cap 173 R.S.M. 1954 and amendments thereto, every Municipal Corporation may pass by-laws for the closing, opening, establishing and maintaining Public Roads within its confines.

AND WHEREAS the Council of the Rural Municipality of Morris desires-

FIRSTLY- To close all that portion of the Public Road between River Lots 495 and 497 of the Parish of St. Agathe in the Province of Manitoba which lies to the East of the production Northerly in a straight line of the Eastern limit of the Public Road as shewn colored Pink on a Plan of same registered in the Winnipeg Land Titles Office as No. 4968 and SECONDLY to open, establish and maintain as a Public Road over and upon all those portions of the South Half of River Lot 493 and the North Half of River Lot 491, both in the Parish of St. Agathe in the Province of Manitoba as shewn outlined in red on a Plan of same made by Chester Gabriel Wesley, M.L.S. on the 23rd and 24th days of September A.D. 1957 and sworn to before A. Lorne Campbell.


AND WHEREAS due publication of Notice of the passing of this by-law has been given in compliance with Section 478 of the afore-said Municipal Act.


NOW THEREFORE The Council of the Rural Municipality of Morris in meeting duly assembled enacts as follows-

FIRSTLY- That all that portion of the Public Road between River Lots 495 and 497 of the Parish of St. Agathe in the Province of Manitoba

which lies to the East of the production Northerly in a straight line of the Eastern limit of the Public Road as shewn colored pink on a Plan of same registered in the Winnipeg Land Titles Office as No. 4968 be closed, and SECONDLY, That a Public Road be opened, established and maintained over and upon all those portions of the South Half of River Lot 493 and the North Half of River Lot 491 both in the Parish of St. Agathe in the Province of Manitoba as shewn outlined in red on a Plan of same made by ~~Chas~~ Gabriel Wesley. M.L.S. on the 23rd and 24th days of September A.D. 1957 and sworn to before A. Lerne Campbell.


AND THAT the Reeve and Secretary-Treasurer of the Rural Municipality of Morris be and are hereby authorized, instructed and empowered on behalf of the said Municipality to execute all necessary documents relative thereto, and for the transference if necessary of all these portions of land in the old road to be closed and for the acquisition of all those portions to be taken for the new road to be opened in the name of Her Majesty the Queen in Right of the Province of Manitoba.
