

RURAL MUNICIPALITY OF MORRIS
By-Law No. 858

Being a By-Law of the Rural Municipality of Morris for the purpose of cancelling certain taxes and hospital accounts.

WHEREAS, Section 1188 of "The Municipal Act" provides for the cancellation of taxes or any debts owing the municipality;

AND WHEREAS the Council of The Rural Municipality of Morris considers it is in the best interests of the municipality to cancel the hereinafter mentioned taxes and hospital accounts owing to the municipality;

NOW THEREFORE, the Reeve and Council of The Rural Municipality of Morris in regular session assembled, enacts as follows:

1. THAT the following TAXES be cancelled as they are considered uncollectable:
