By-Law No. 877

WHEREAS, Sec. 1188 of the "Municipal Act" provides for the cancellation of taxes or any debts owing the municipality,

AND WHEREAS the Council of the Rural Municipality of Morris considers it is in the best interests of the municipality to cancel the herein-after mentioned taxes and hospital accounts;

NOW therefore, the Reeve & Council of the Rural Municipality of Morris in regular session assembled, enacts as follows:
