BY-LAW No. 899

WHEREAS, Sec. 1188 of "The Municipal Act" provides for the cancellation of taxes or any debts owing the municipality;

AND WHEREAS the Council of the Rural Municipality of Morris considers it is in the best interest of the municipality to cancel the herein-after mentioned taxes and other debts;

NOW THEREFORE, the Reeve and Council of the Rural Municipality of Morris in regular session assembled, enacts as follows:
