

BEING By-Law No. 918 of the Rural Municipality of Morris,  
Relative to the sale of certain property.

WHEREAS Main Construction Limited has offered to purchase  
from the Rural Municipality of Morris the following described land,  
namely:

"ALL AND SINGULAR that certain parcel or tract of land  
and premises situate lying and being in the Sixth Township  
in the Second Range, West of the Principal Meridian in the  
Province of Manitoba, being that portion of the North-West  
Quarter of Section Twenty-nine in said Township more partic-  
ularly described as follows:- Commencing at the South-East  
angle of said Quarter section, thenceWesterly along the  
Southern boundary thereof One hundred and Seventy-five feet  
thence Northerly parallel with the Eastern boundary of said  
Quarter Section to the Right of Way of the Morden and North  
Western Railway Company Right of Way as said right of way  
is shown on a Plan thereof filed in the Winnipeg Land Titles  
Office; thence Easterly and Northerly along the Southerly  
limit of said right of way to the Eastern boundary of said  
quarter section, thence Southerly along said Eastern boundary  
to the South-East angle of said Quarter section, the point of  
commencement - containing one acre more or less with the  
further right of ingress and egress over that portion of the  
said north-west Quarter of said Section Twenty-nine, ext-  
ending fifteen feet wide along the said Southern Boundary of  
said quarter section from the South-West corner of the portion  
hereinbefore described and conveyed, Westerly to the Station  
grounds of the said Railway as shewn on said Plan, thence  
Southerly over that part of the South-West Quarter of said  
Section twenty-nine fifteen feet in width along the Easterly  
and Southerly limits of said Station Grounds to the Easterly  
limit of Station Street as said Street is shown on said Plan."

at and for the sum of Two hundred and fifty (\$250.00) Dollars.

AND WHEREAS the consideration is deemed fair and reasonable.

NOW THEREFORE BE IT ENACTED, and it is hereby enacted as  
By-law No. 918 of the Rural Municipality of Morris:

1) THAT the Rural Municipality of Morris sell and convey  
to Main Construction Ltd. the following described land, namely:

"ALL AND SINGULAR that certain parcel or tract of land  
and premises situate lying and being in the Sixth Township  
in the Second Range, West of the Principal Meridian in the  
Province of Manitoba, being that portion of the North-West  
Quarter of Section Twenty-nine in said Township more partic-  
ularly described as follows:- Commencing at the South-East  
angle of said Quarter section, thenceWesterly along the  
Southern boundary thereof One hundred and Seventy-five feet  
thence Northerly parallel with the Eastern boundary of said  
Quarter Section to the Right of Way of the Morden and North  
Western Railway Company Right of Way as said right of way is  
shown on a Plan thereof filed in the Winnipeg Land Titles  
office, thence Easterly and Northerly along the Southerly  
limit of said right of way to the Eastern boundary of said  
quarter section, thence Southerly along said Eastern boundary  
to the South-East angle of said Quarter Section, the point of

fifteen feet wide along the said Southern Boundary of said  
quarter section from the South-West corner of the portion

hereinbefore described and conveyed, Westerly to the Station grounds of the said Railway as shewn on said Plan, thence Southerly over that part of the South-West Quarter of said Section twenty-nine fifteen feet in width along the Easterly and Southerly limits of said Station Grounds to the Easterly limit of Station Street as said Street is shown on said Plan."
