BY-LAW No. 925

WHEREAS, Sec. 1188 of "The Municipal Act" provides for the cancellation of taxes or any debts owing the municipality;

AND WHEREAS the Council of The Rural Municipality of Morris considers it in the best interest of the municipality to cancel the hereinafter mentioned taxes and accounts receivable;

NOW THEREFORE, the Council of the Rural Municipality of Morris in a regular session assembled, enacts as follows:
