BY-LAW No. 935

WHEREAS, Sec. 1188 of "The Municipal Act" provides for the Cancellation of taxes or any debts owing the municipality;

AND WHEREAS the Council of The Rural Municipality of Morris considers it in the best interest of the municipality to cancel the hereinafter mentioned taxes;
