

BY-LAW No. 942

RURAL MUNICIPALITY OF MORRIS

being a By-law of the Rural Municipality of Morris to merge the School District of Greenbank # 2124, School District of Rosenort # 60, School District of Rosenhoff # 61, School District of MacTavish # 1029, School District of Clover Plains # 2292, School District of Flowery Bank # 837 and School District of Pleasant Valley # 862 to form a consolidated School district.

WHEREAS, under section 7 (1) (g) of The Public Schools Act, the council of a rural municipality on its own initiative, or on the petition of the Board of Trustees or of any four electors of the territory effected, may, by by-law, unite two or more districts in the same municipality into one, if a majority in number of the resident electors of each such district present at any annual or special meeting pass resolutions requesting the council to pass such by-law;

AND WHEREAS a special meeting has been held in each school district concerned at which a majority of the resident electors present and voting passed resolutions in favour of the consolidation;

AND WHEREAS a petition signed by at least four resident electors of the territory involved was present to the council of the Rural Municipality of Morris and to the Inspector of Schools, praying for the merger of the said school districts to form a consolidated school district;

AND WHEREAS due notice in writing, setting out the time and place at which the matter would be dealt with, was mailed to the last known address of the Secretary-Treasurer of every school district and of the school division concerned, and every rate-payer whose lands would be effected by the proposed action;

AND WHEREAS all interested parties present and wishing to be heard were given an opportunity to be heard;

NOW THEREFORE the council of the Rural Municipality of Morris in council assembled enacts as follows:

1. That the School Districts of Greenbank No. 2124, Rosenort No. 60, Rosenhoff No. 61, Clover Plains No. 2292, MacTavish No. 1029, Flowery Bank No. 837 and Pleasant Valley No. 862 be ~~united~~ dissolved;
2. That the School Districts of Greenbank No. 2124, Rosenort No. 60, Rosenhoff No. 61, Clover Plains No. 2292, MacTavish No. 1029, Flowery Bank No. 837 and Pleasant Valley No. 862 be united unto one school district to be known as The Consolidated School District of Rosenort No. 2455;
3. THAT the assets of each school district hereby merged be vested in The Consolidated School District of Rosenort No. 2455 and be used to meet the operational and capital expenditures of the said School District;
4. That all the debts and liabilities, including debenture debt, of each district hereby merged be assumed by The Consolidated School District of Rosenort No 2455 and be chargeable on, and levied against, the lands comprised in the said school district;

5. That this By-law shall come into effect as of, on, and from the 1st day of January, A. D. 1967.
