

BY-LAW NO. 964

Being a By-law of the Rural Municipality of Morris relating to voting of resident electors of the Consolidated School District of Rosenort No. 2455 in connection with the construction of an elementary school.

WHEREAS the Consolidated School District of Rosenort No. 2455 has given second reading to By-law No. 1-1967 to authorize the Trustees of the said School District to borrow the sum of Four Hundred Thousand (\$400,000.00) Dollars by the issue and sale of debentures of the said School District for the purpose of building a new elementary school;

AND WHEREAS pursuant to Subsection 4 of Section 220 of The Public Schools Act, every such By-law shall be submitted to the electors for their assent in the manner required by The Municipal Act;

AND WHEREAS Section 539 of The Municipal Act sets forth the manner in which the By-law shall be submitted;

AND WHEREAS Section 539 (b) and (c) of The Municipal Act enact as follows:

539(b) The corporation shall, by a separate By-law:

(i) fix the day and hour when and the place or places where the votes are to be taken, and

(ii) fix a time when and a place where, the clerk is to sum up the number of votes given for and against the proposed By-law, and a time and place for the appointment of persons, to represent those interested respectively in promoting or opposing the passage of the proposed By-law, to attend at the various polling places and at the final summing up of the votes by the clerk.

539(c) The day fixed under sub-clause (i) of Clause (b) shall not be fewer than three or more than five weeks after the first publication of the notice respecting the taking of votes on the proposed By-law.

NOW, THEREFORE, BE IT ENACTED AND IT IS HEREBY ENACTED as By-law No. 964 of the Rural Municipality of Morris in Council duly assembled, as follows:

- 1. THAT Monday, the 16th day of October, A.D. 1967 between the hours of 9:00 o'clock in the forenoon and 6:00 o'clock in the

afternoon/for the taking of the vote to be taken under By-law No.  
1-1967 of the Consolidated School District of Rosenort No. 2455;

2. THAT the polling place for the taking of the vote be the  
Rosenort Firehall in Rosenort, Manitoba.

3. THAT Friday, the 13th day of October, A.D. 1967 at the  
hour of 2:00 o'clock in the afternoon at the Municipal Office in  
the Town of Morris, in Manitoba, be the time and place for the  
appointment of persons to represent these interested respectively  
in promoting or opposing the passage of the proposed By-law to  
attend at the polling place and the final summing up of the votes  
by the clerk.

4. THAT Monday, the 16th day of October, A.D. 1967 at the  
hour of 8:00 o'clock in the afternoon, at the Municipal Office in  
the Town of Morris, in the Province of Manitoba be the time and  
place where the clerk shall sum up the number of votes given for  
and against the proposed By-law.
