

BY-LAW No. 988

Being a By-Law of the Rural Municipality of Morris.

WHEREAS the Morris Hospital District No. 25 has formulated a Supplementary Scheme for the purchase of land for the Morris General Hospital;

AND WHEREAS said Supplementary Scheme has been approved by the Honourable Minister of Health and Social Services;

AND WHEREAS the Rural Municipality of Morris has received a copy of the Supplementary Scheme;

NOW THEREFORE BE IT AND IT IS HEREBY ENACTED AS FOLLOWS:

1. THAT the Supplementary Scheme for the Morris Hospital District No.25, attached hereto and marked schedule "A" to this By-law, be and is hereby approved by the Rural Municipality of Morris.

2. THAT the ~~Reeve~~ and the Secretary-Treasurer be and they are hereby empowered to do all things necessary to signify the approval hereby granted, including without limiting the generality of this section, submitting certified copies of this By-law together with the Supplementary Scheme referred to attached as a Schedule thereto, to:

- a) W.J.Hamblin, Chairman of the Governing Board, The Morris Hospital District No.25;
- b) The Manitoba Hospital Commission.
