The Council of The Rural Municipality of Morris held its regular meeting on the above date with all members present. The minutes of the August 9th meeting were read and adopted by motion of C.J. Neufeld and Ed. Saurette.

- Request for access road to be extended to P.T.H.#3, on a 100% Government Share Basis M. Ribordy-Wm. F. Schellenberg: Whereas the "Access Road" into the Village of Sperling is about to be black-topped up to "Waddell Street" (see map attached) at 100% Government share of costs; And whereas the ratepayers of the Village of Sperling have requested that said access road be extended Southerly, passed the Sperling Collegiate, United Church and Catholic Church and connecting to P.T.H. #3 to the South of Sperling, thus servicing School Vans and parishioners alike; Now therefor the Council of the Rural Municipality of Morris requests the Minister of Public Works to give this project his favorable consideration on a 100% Government share basis.

- Alterations by Imperial Oil Approved. Otto Bunkowsky-Wm. F. Schellenberg: That we approve of the proposed alterations, by Imperial Oil Ltd., to the existing Bulk Plant facilities at Rosenort, Man., as set out in Drawing No. 5-B-6300-1.

- By-Law 908 Re Land Sale passed. Otto Bunkowsky-C. J. Neufeld: That By-Law 908 being a By-Law for the purpose of selling to Mogens Nielsen of Winnipeg--The N 10 Rods of W 10 Rods of SW 32-6-2WPM for the sum of \$1.00 plus cost of transfer fees, having been read a first time, be now considered as having been read a second and third time and passed.

- Licence Inspectors Appointed. Ed. Saurette-Wm. F. Schellenberg: That we appoint the following Licence Inspectors to assist in enforcing Pedlar's Licence By-Law No. 775:

Ward 6: Mrs. M. Davidson and that a \$10.00 fee be paid the Inspector who causes a Pedlar to purchase a Licence.

- Municipal Aid. Ed. Saurette-Wm. Recksiedler: That we pay \$20.00 a month aid to Effie Mihiaczuk of Aubigny, commencing September 1, 1963.  
Carried.
- Committee Members Re Senior Citizen's Home. Ed. Saurette-Wm. F. Recksiedler: That we appoint Wm. F. Schellenberg and Bruce MacKenzie as our members to a committee, which will study the financial aspects of constructing a Senior Citizen's Home in the Town of Morris.  
Carried.
- Request to W.C.&S Re Drain. Wm. F. Recksiedler-Ed. Saurette: That we request the Water Control & Conservation Branch to purchase the Right-of-Way for Drain running through Sections 15 and 16, Twp. 4, Rge. 1, E.P.M.  
Carried.
- Accounts. Otto Bunkowsky-Wm. Recksiedler: That the accounts as approved by the Finance Committee for \$57,696.62 be passed for payment.  
Carried.
