December 13, 1968

The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. G.Cretton moved, seconded by B.Klassen that the minutes of November 8th Council meeting be adopted as read.

H. D. Earl-W.F.Recksiedler: That we make a grant of \$25.00 towards the Santa Claus Day, as sponsored by the Morris Branch of the Canadian Legion. Carried

G. Goossen-B.Klassen: That By-Law No. 982, being a by-law for the purpose of Cancelling certain Taxes and Accounts Receivable, having been read a first time, be now read a second and third time & passed. Carried

Ben Klassen-G.Goossen: That we make the following donations:  
Rosenort Community Centre ..... \$300.00  
Lowe Farm Curling Rink ..... \$100.00  
Lowe Farm Skating Rink ..... \$100.00  
Aubigny Hockey Club ..... \$200.00 Carried

Harold Earl-G.P.Goossen: That By-Law No. 976 being a by-law for the purpose of transferring the lands of the Carleton S.D. #36 to the Morris Consolidated S.D. #2421, having received the approval of the Minister of Education, be now given third reading and passed. Carried

Ben Klassen-Gib. Cretton: That the commission of Hospital premium collections be allocated to the municipal staff with the exception of \$100. per Benefit Period, which amount is to be credited to the Postage & Stationery account. Carried

H.DD. Earl-G.Cretton: That the appeals of the Assessor, as set out in Exhibit B-1 covering Changes of Ownership, Assessment Values, etc., be approved. Carried

W. F. Recksiedler-Ben Klassen: That the next regular monthly meeting be held on JANUARY 7th (succeeding the Inaugural Meeting) instead of on January 10th, 1969. Carried

H. Earl-W.Recksiedler: That the accounts as approved by the Finance Committee for \$188,069.61 be passed for payment. Carried

The annual Tax Sale was held with only two small parcels of land being sold at same.

Representatives from the Rosenort Community Centre attended to solicit financial support for its skating rink. Strong encouragement was given to form a local improvement area in this district, thus permitting levying for its needs through taxation.

Peter Langes, architect, gave a progress report on the Municipal Building. With most discrepancies taken care of, final payment to the contractor can now be made.

A discussion followed on the subject of Non-Ward operation and accounting, as recommended by the Finance & Budget department of the government.

Another subject of prime importance, namely a Public Works Foreman, received considerable attention with further study to follow.

The Meeting adjourned, after which  
The Council, staff and councillors wives all gathered at the residence of George P. Goossen's, Rosenort, for a Christmas Dinner.
