Revision

Moved by George St. Hilaire, Seconded by Glenn Curdt:
#1/88. Resolved that the Council of the Rural Municipality of Morris now become the Board of Revision for the Rural Municipality of Morris for the 1987 additional assessments and the 1988 property assessments.

Carried.

Prior to the start of the Board of Revision, Mr. Jim Hunt of the Municipal Assessment Office in Morden was sworn in. In addition to this, the following persons were also sworn in or affirmed as they made their presentations to the Board of Revision on behalf of their appeals. There people were: Russ Nicolajsen, R. Following all of the presentations made for each of the appeals, the Board of Revision then decided upon the appeals.

Appeal 1
M. Heiderich

Moved by Larry Gluck, Seconded by Allan Dickson:
#2/88. Whereas Mr. Manfred W. Heiderich has appealed the taxable building assessment on the E. 500 ft. of the S $\frac{1}{2}$ of the S $\frac{1}{2}$ of Section 28-5-1West on the basis that most of the site is used for agricultural purposes;
Therefore Be It Resolved that the decision of the Board of Revision is that the building assessment be sustained.

A. Paetkau


Moved by Glenn Curdt, Seconded by Dave Waldner:
